



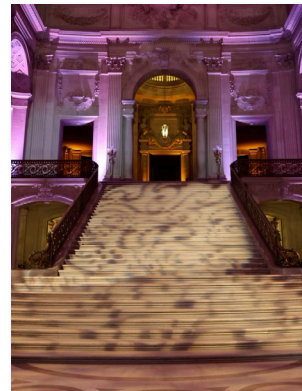

What is Type 1 Diabetes (T1D)?

T1D is a chronic autoimmune disease in which a person’s pancreas stops producing insulin, a hormone people need to get energy from food. T1D strikes both children and adults, and its onset has nothing to do with diet or lifestyle. People with T1D depend on external insulin, via injection or infusion with an insulin pump, to survive. There are no cures. Breakthrough T1D is working to change that.

Breakthrough T1D (Formerly JDRF)

As the leading global T1D research and advocacy organization, Breakthrough T1D helps make everyday life with T1D better while driving toward cures. We invest in the most promising research to turn ideas into life-changing therapies and devices. We work with government, regulatory officials, and insurance companies to address issues that impact the T1D community—breaking through barriers that limit access to care worldwide. We provide resources and guidance that makes it easier to live and thrive with T1D.

Our mission is to improve lives today and tomorrow by accelerating life-changing breakthroughs to treat, prevent, and, ultimately, cure T1D and its complications. Always, we are guided by a single purpose:

As we drive toward curing T1D, we help make everyday life better for the people who face it.

Currently, 1.6 million Americans are living with T1D, impacting 1 in 31 families.
 In 2024, 52,000 people were diagnosed in the U.S. alone.
 With 2.1 million people projected to develop T1D by 2040, we cannot afford to fall behind.

More than half (56%) of all people newly diagnosed with T1D are adults aged 20 and older.
 Nearly 85% of diagnoses occur in people who have no family members with the disease.

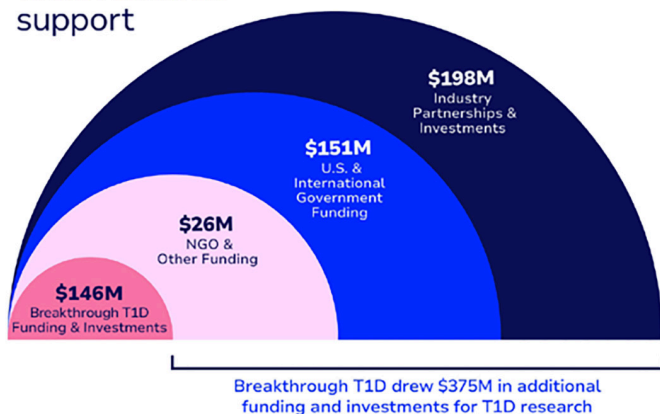

Breakthrough T1D invested \$146M in research, and through our influence within the public and private sectors, we helped raise another \$375M

A total of \$521 million—through funding from other organizations, corporations, and governments, in addition to Breakthrough T1D—for T1D research and therapy development

Of that \$521 million, the T1D Fund—our venture philanthropy fund established to address the lack of private investment in T1D therapy research and development—catalyzed \$146M* in private investment in companies developing T1D treatments
