E. Terms and Conditions of Sponsorship

I understand that the event listed above is organized by Breakthrough T1D, where participants raise money for diabetes research. Sponsor will donate the amount described above to Breakthrough T1D. This sponsorship payment may be used and/or distributed when and as Breakthrough T1D deems appropriate, in its sole discretion, in furtherance of Breakthrough T1D's charitable mission and to pay for expenses. If a sponsorship goods and services schedule is attached to this agreement, only the portion of the sponsorship payment that exceeds the fair market value of the goods and services as outlined will be a "Qualified Sponsorship Payment" as defined in Section 513(i) of the Internal Revenue Code, and the regulations pertaining thereto. Sponsor made the charitable contribution with no arrangement or expectation that the sponsor would receive any substantial return benefit, except as provided in the attached sponsorship goods and services schedule.

Breakthrough T1D may, without any cost or expense to Sponsor, acknowledge Sponsor in the same or similar manner as it recognizes other corporate sponsors that provide a comparable level of support. For purposes of this Agreement, all recognition or acknowledgement of Sponsor provided by Breakthrough T1D shall be within the definition of a "use or acknowledgment" as defined in Treasury Regulations Section 1.513-4(c). All recognition or acknowledgement of Sponsor provided by Breakthrough T1D shall not be "advertising" as defined in Treasury Regulations Section 1.513-4(c). Breakthrough T1D shall not endorse or otherwise promote any of Sponsor's products or services.

Sponsor understands and agrees that Breakthrough T1D retains all ownership rights in the Marks (including the right to control the quality of all usage thereof). Sponsor understands and agrees that any use of the Marks in the territory and/or on the Internet is subject to the prior written approval of Breakthrough T1D, such approvals not to be unreasonably withheld or delayed. Accordingly, Sponsor agrees to submit for approval to Breakthrough T1D: (i) all printed material (e.g., brochures, flyers, posters, invitations, etc.) which contains the Marks; and (ii) all publicity releases and advertising which mention the Marks (whether television, radio, newspaper, billboard, Web pages or any other form), prior to the printing, distribution, broadcast, or publication thereof. Sponsor understands and agrees that the Marks: (i) may not be altered in any way, nor may they be sublicensed to any other person or entity; (ii) may not be used in conjunction with terminology that is contrary to Breakthrough T1D's mission (iv) may not use the Marks in any way that would imply endorsement or advertisement of any product or service or which could harm or otherwise diminish the good name and good will of Breakthrough T1D. Upon the expiration or termination of this Sponsorship, the Parties shall discontinue use of each other's marks unless expressly authorized to the contrary in writing.

Each party will indemnify, defend and hold harmless the other party against any third-party claims and all resulting liabilities, losses and costs (including reasonable attorneys' fees) arising out of: (a) any negligence, willful misconduct or breach of this sponsorship by the indemnifying party, and (b) the sale, use or advertising of any products or services of the indemnifying party. Each party will give the other prompt notice of any such claim. The indemnifying party shall have the right to control the defense of the claim. The indemnified party may participate in the defense at its own expense.

All contributions hereunder shall be promptly paid by Sponsor to Breakthrough T1D. In recognition of Sponsor's support, Breakthrough T1D will act in good faith and provide benefits in accordance with the agreed-upon level selected. Sponsor will send a high-resolution EPS file of Sponsor's corporate logo to be used for printing on materials that apply to their sponsorship level to the staff member Sponsor is working with.

Nothing contained herein shall be construed in any way to create a joint venture, partnership, agency, or other similar relationship between Breakthrough T1D and Sponsor, and it is the specific intent of the Parties that no such relationship be established hereby. None of the Parties shall have any express or implied right or authority to assume or create any obligations on behalf, or in the name, of any other Party, or to bind any other Party to any contract, agreement, or undertaking with any third party.

Sponsor authorizes Breakthrough T1D to use: (a) Sponsor name and/or (b) any photographs or logos which Sponsor has provided to representatives of Breakthrough T1D to promote or advertise the **events chosen above**. Such promotion or advertising may include, but is not limited to, the publication, display, and exhibition of Sponsor's name and/or photographs. Except for the duty to make payments hereunder when due, and the indemnification provisions above, neither Party shall be responsible to the other for any delay, damage, or failure caused or occasioned by a Force Majeure Event. As used in this Agreement, "Force Majeure Cause" shall mean: **Any act of God; act of nature**; terrorism, insurrection, revolution or civil strife; piracy, civil war or hostile action; labor strikes; acts of public enemies; federal or state laws, rules and regulations of any governmental authorities having jurisdiction over the premises enacted after this agreement and which directly impact the ability to perform; inability to procure material, equipment, or necessary labor in the open market; acute and unusual labor, material, or equipment shortages, or any other causes (except financial) beyond the control of either party. Delays due to any of the above causes shall not be deemed to be a breach of or failure to perform under this Agreement. If the Event must be rescheduled due to a Force Majeure cause, the amount committed on this form will be transferred to the new event date, and the benefits, acknowledgement and recognitions agreed upon at the selected level will be transferred to the new date.

Unless otherwise provided for in the Agreement, Sponsor, at its own expense, will remit the donation(s) described above to Breakthrough T1D within forty-five (45) days of the Effective Date of this Agreement. Sponsor will be responsible for notifying Breakthrough T1D that the donation was made, as well as the amount, method of payment, and any other details that will allow Breakthrough T1D to identify the donation and attribute the sponsorship.

Breakthrough T1D does not accept payments from Donor Advised Funds, employer matching gifts, or point-of-sale campaigns for corporate sponsorships.
